Did you miss the ICRM's annual business meeting? Don't worry you can watch it via our <u>YouTube channel</u>.

The Regents announced the following during the meeting:

- 1. **6 Month CMP Rule Change to 12 months**: Approval of rule change that CMPs must be submitted within 6 months of the activity date to 12 months of the activity date. This means members will now have a full year from the activity date to submit their CMPs.
- 2. Reinstatement of Rollover Policy Once Technology Allows:

Reinstatement of 50 CMP Rollover Policy for CMPs earned within the last year of their cycle to be implemented once technology allows. This means that once the technology allows, members will start being able to accumulate up to 50 Rollover CMPs within the last year of their cycle. There are several technology projects ahead of this, but hopefully, this will be released sometime in 2024.

January is National Mentor Month. Deborah Robbins, Mentoring Committee Chair has provided a short article about the mentoring program and its benefits. Were you aware that mentors can receive up to 30 CMP points per year?

Wanted: ICRM Mentors

The ICRM Mentoring Program continues to grow with each passing year. Although the mentoring program, including mentors for all six exam parts, didn't start until 2019, we continue to see requests for mentors grow exponentially each year. With 800+ candidates currently working towards certification, we are always in need of individuals to mentor our candidates.

What's in it for me? I like to think of myself as generous and kind, but taking on a new commitment can sometimes bring out the "dark" side and I am often asked, "What benefits are there for mentors?". So I wanted to take a few moments to share some of the benefits you receive as an ICRM mentor.

- 1. Mentors can receive up to 30 CMP points in a year.
- Mentors can keep current with RIM concepts and technologies. I find that when I am working with mentees, I often learn about new technologies and techniques that they are learning about or using in their own work.
- 3. Mentors grow their RIM network. While you serve as a mentor, you also add quality individuals to your network. These relationships can last a lifetime!
